# **Membership Application and Consent Form**

The Global Network of Sex Work Projects (NSWP) is a private not-for-profit company registered in Scotland, UK. **Members should note that NSWP is not a donor and does not have funds to distribute to members.** 

The aims of NSWP are to:

1. Your Organisation

- Provide practical information and opportunities for information sharing among organisations and projects, which provide services to male, female and transgender sex workers;
- Raise awareness of the health and welfare needs of sex workers;
- Advocate at regional and global level for policies and action, which further the human rights of sex workers<sup>1</sup>;
- Develop and maintain links between service providers, sex worker organisations and relevant international institutions and agencies;
- Facilitate opportunities for the voices of sex workers to be heard in relevant international forums.

These rights include the right to health and a safe working environment free from abuse, violence, and discrimination as set out in the <u>NSWP Members Consensus Statement</u>

The term 'third parties' includes managers, brothel keepers, receptionists, maids, drivers, landlords, hotels who rent rooms to sex workers and anyone else who is seen as facilitating sex work.



#### 1.6. Sex Worker-Led Status

Organisations/groups must meet at least two of the three following criteria to qualify as sex worker-led organisations with voting rights, regardless of their self-definition:

- <u>Decision-making body</u>: 50% or more of the decision-making body must be sex workers (individuals who formerly or currently have engaged in sexual labour of any kind and who self-define as 'sex workers' with an aspiration to include current sex workers although not an absolute requirement). If not, what is the mechanism that ensures sex workers are in control of the organisation's activities and advocacy?
- **Spokespeople**: 50% or more of the spokespeople must be sex workers. If not, please indicate what transparent mechanisms are in place for ensuring the voices of sex workers are heard.
- Staff: 33% or more of the staff are sex workers and have the same contracts and working conditions as other staff in the organisation e.g. sex workers are not only employed as peer educators on minimal pay.

**Note:** For both safety and security NSWP does not identify which members are sex worker-led on our website, and members can choose not to be listed on the public website.

#### 2. NSWP listservs

New members are automatically added to three NSWP listservs: the members listserv; the members-discussion listserv; and regional listservs. The organisation's contact email address is added to all three listservs and each member must provide an additional three contacts to be added to the members-discussion and regional listservs.

**NSWP members listserv (announce only)** is used to share minutes of the NSWP Board meetings, and announcements about elections for regional representatives on the NSWP Board of Directors and the NSWP Presidential election. It is the only email address that your organisation can use to send nominations and votes during elections.

**NSWP** members-discussion and regional listservs facilitate communications among NSWP members within and across regions. Each member organisation is asked to provide an additional 3 email addresses to be added to these listservs so that different people in your organisation can participate in the global & regional discussions.
